President Report	The President's report was sent in advance for review. He

	too.
Year in review	The President covered the ICCC mandate, vision, mission and
	strategy. ICCC celebrated Pravasi Bharathiya Divas day with
	the collaboration of the High Commission of India and other
	organizations. There has been excellent rapport between ICCC
	seniors and Deshantari seniors with joint events, and
	information sharing, including on grants process.
